- North Suburban Consortium
- 4 Entitlements: Arlington, Malden, Medford, & Revere
- 4 Non Entitlement: Chelsea, Everett, Melrose, & Winthrop
- Annual grant \$1.5 to \$2.0 Million
- Homebuyer assistance, rehab, rental development
- One and ½ staff dedicated to HOME
- 90 rental properties in portfolio

Currently Working On

- 3 rental developments in pipeline
 - Underwriting, subsidy layering, environmental
- Problem solving with 2 older rental developments
- New 5-year (2020-2025) Con Plan
- Almost continuous monitoring of our 90 rental developments

Rental Monitoring Requirements

- A system for monitoring [92.504(a)]
- Conduct on-site inspections [92.504(d)(1)]
- Review tenant income and rents [92.252(f)(2)]
- Filling vacancies and maintaining unit mix – High and Low Home Rents [92.252(i) and (j)]
- New rent approvals [92.252(f)(2)]
- Owner cert. bldg condition [92.504(d)(1)(ii)(c)]
- Financial condition, 10 or more [92.504(d)(2)]

Structuring a Monitoring Plan

- Desk Reviews
 - Rents and Income
 - Financial reports
- On Site Reviews
 - Physical inspections
 - 1/3 each year
 - General condition of property, files
 - Income calculations
 - Based on risk assessment

Monitoring Challenges

- Old Home Agreements or Affordable Housing Restrictions Poorly Written
- Affordability restrictions beyond the minimum required by regs.
- Multiple monitors when state funding
- Changes in owner/management personnel (particularly non profits)
- Developing staff expertise

Common Issues and Findings

- Rent increases not requested
- Owner confusion on floating or fixed
- Misunderstanding allowable rent for units with mobile voucher
- Changes in use
- Inadequate maintenance
- Meshing homeless programs with HOME
