FY22 Transportation-HUD (THUD) Appropriations Update

- ◆ NCDA advocacy process
 - ◆ February – December and beyond
 - ◆ CDBG/HOME coalitions
 - ◆ Ongoing communication with THUD staff
 - ◆ Advocate for program changes too
- ◆ CDBG, HOME, and HUD Homeless Assistance Grants will be increased in FY22

FY22 House THUD Bill

- ◆ Status of House THUD bill
- ◆ Funding for CDBG, HOME, HUD Homeless Assistance Grants
 - ◆ \$3.75 billion for CDBG
 - ◆ \$935 million for EDIs
 - ◆ \$1.850 billion for HOME
 - ◆ \$3.42 billion for Homeless Assistance Grants

FY22 Senate THUD Bill

- ◆ Status of Senate THUD bill
- ◆ Proposed funding for CDBG, HOME, HUD Homeless Assistance Grants
 - ◆ \$3.55 billion for CDBG
 - ◆ \$615 million for EDIs
 - ◆ \$1.45 billion for HOME
 - ◆ \$3.26 billion for Homeless Assistance Grants
- ◆ Completion of appropriations process
- ◆ Continuing Resolution (CR) through December 3

Authorizing Language in the FY22 THUD Bill

- ◆ House THUD Bill
 - ◆ CDBG formula study
 - ◆ GAO study on HUD capacity
- ◆ Senate THUD Bill
 - ◆ CDBG-DR program

Build Back Better Act

- ◆ \$1.75 trillion spending and tax bill
- ◆ \$150 billion for affordable housing and community development spending
- ◆ Historic levels for the HOME program, public housing, Housing Trust Fund, and rental assistance.
- ◆ HOME Program exemptions
- ◆ CDBG Funding
- ◆ New CDBG eligible activity
